The resolutions included an ordinary resolution increasing the authorised share capital of the company from £17,500,000 to £21,000,000 by the creation of (i) 4,000,000 ordinary shares of 25p each ranking pari passu with the existing ordinary shares of 25p each and (ii) 2,500,000 9 per cent cumulative preference shares of £1 ranking pari passu with the existing 9 per cent cumulative preference shares of £1 each.
